ITINERARY

February 24 - Depart the USA in the evening

February 25 - Arrive in Tel Aviv

Arrive in Tel Aviv in the late afternoon or early evening. Overnight in Netanya.

February 26 - Theme: Coastal Plain and the Via Maris

Morning: Caesarea, built by Herod the Great; the residence of Pilate, procurator of Judaism, Cornelius, the centurion (Acts 10), Herod Agrippa, who killed James (Acts 12), and Festus to whom the Apostle Paul was taken for questioning (Acts 25).

Afternoon: Megiddo, the battleground of history (1 Kings 9:15; 2 Kings 23:28; Revelation 15:12), and Magdala, home of Mary Magdalene. Overnight at Magdala OR Tiberius.

February 27 - Theme: Jesus' Early Years

Morning: Chorazin (Matthew 11:21; Luke 10-13), Zippori National Park, the early capitol of Galilee, Nazareth, the childhood home of Jesus.

Afternoon: The Church of the Annunciation, Nazareth Village, a working first-century village, Mount Arbel National Park. Overnight in Magdala or Tiberius.

February 28 - Theme: Jesus Ministry around the Sea of Galilee

Morning: Boat ride on the Sea of Galilee, See the ancient boat at Kibbutz nof Ginnosaur; Capernaum, the Town of Jesus (Matthew 4:13; Mark 3:1, 8:5) and home of Peter.

Afternoon: Mount of Beatitudes (Matthew 5-7), Tabgha, Church of the Multiplication and Church of the Primacy where Peter was asked "Do you love me?" (John 21), Cave of Eremos. Overnight in Magdala or Tiberius.

February 29 - Theme: Jewish Presence in the Golan Heights and the Upper Galilee

Morning: Kursi, the area where evil spirits were cast into swine (Mark 5) Gamla (an important city of the first Jewish Revolt); Golan Heights and the region of Mount Hermon (Probable location of the Transfiguration – Matthew 17); Banias National Park (Peter's Confession in Matthew 16:13)

Afternoon: Tel Dan where Jeroboam set up idol worship (1 Kings 12:29). Overnight in Magdala or Tiberius.

March 1 - Theme: Jewish Presence in The Jordan Rift Valley

Morning: Beth Shean, Old Testament Tel and New Testament Roman City (I Samuel 31:10)

Afternoon: Jericho (Joshua 5-7), Qumran, an Essene Community who preserved the Dead Sea Scrolls. Overnight at the Dead Sea.

March 2 - Theme: The Jewish Revolt at Masada

Morning: Masada, the last Zealot stronghold against Rome in 70 AD *Afternoon:* Free time at the hotel and the Dead Sea. Overnight at the Dead Sea.

March 3 - Theme: David at En Gedi, and Jesus at the Jordan

Morning: En Gedi National Park with a walk to the Falls.

Afternoon: Baptismal site at Jordan River, Wadi Qelt. Overnight in Jerusalem.

March 4 - Theme: The Births of John the Baptist and Jesus

Morning: Ein Karem, Israel Museum and the Book of the Shrine (Possible visit to the Holocaust Museum at Yad Vashem).

Afternoon: Bethlehem and the Church of the Nativity, Shepherds' Field, a possible visit to Herodion (built by King Herod). Overnight in Jerusalem.

March 5 - Theme: Jesus' Triumphal Entry into Jerusalem

Morning: Starting on the Mount of Olives, descending to the Garden of Gethsemane, then followed by a visit to St. Peter of Gallicantu church (the crow of the Rooster)

Afternoon: The City of David, King David's Jerusalem, David's Palace, Warren's Shaft, Hezekiah's Tunnel and the Gihon Spring, the Pool of Siloam. Overnight in Jerusalem.

March 6 - Theme: Jerusalem during the Passion Week

Morning: The Western Wall and tunnel: first-century level of the Western Wall, the Teaching Steps of Christ (Matthew 21) and the Temple Mount.

Afternoon: Via Dolorosa, Pool of Bethsaida and St. Anne Church, the Church of the Holy Sepulcher and the Garden Tomb.
